• What are the main changes that need further investigation?

Changes are already known:

- 7 fewer non-completions (25 → 18), compared to the original HEIFES prediction.
 (Improved completion rates)
- 13 part-time students were predicted for a January start in HEIFES, but these didn't arrive. (Column 2 figures show 7 fewer students in price group B, 6 fewer in price group C2).

• What are the main changes that need further investigation?

Extra students have been excluded, beyond the 96 FE students. This is due to errors in the ILR:

- ≈25 extra (121-96) students have been specifically excluded (EXCL4).
- 10 students have been excluded because they have an FTE less than 3% (EXCL8).

Shifts in provision:

- -47 countable years (-29 column 1, -18 column 2)
- 12 fewer non-completions (-25 → -13) (improved completion rate)
- -43 Home & EU fundable years, -2 non-fundable, -2 I&OS

Individualised file errors

• BEng in Electrical Engineering: all 15 students have a blank FUNDLEV field. One of these is also excluded as they withdrew before the census date (EXCL 32)

- they're specifically excluded (EXCL 4)
- accounts for 14 fewer fundable PT, UG, Price group B, standard years, all in Column 1
- MA in Fine art: all 10 students have MODESTUD set to 99.
 - they're specifically excluded (EXCL 4)
 - o accounts for 6 fewer fundable, 2 fewer non-fundable, 2 fewer I&OS, all Column 1.
 - Of the 6 fewer fundable students, they are FT, PGT (Masters loan), price group C1, long years
- HND in construction (PT yr1): 10 students have STULOAD entered as 0.666 instead of 66.
 - They're excluded as the FTE is too low (EXCL 8)
 - Accounts for 10 fewer fundable, PT, UG, standard years. These are split 50% in price group B, 50% in price group C2. Five students are Column 1, 5 are Column 2.
- Plus the differences present in the 'normal' version (7 fewer non-completions and -13 years in column 2)
- 6 of the excluded students were non-completions (HEFCOMP = 3), which explains the extra improvement in non-completions

• What are the main changes that need further investigation?

The same students have been excluded as in the 'normal' scenario

- 96 FE students (EXCL 2 and EXCL 4)
- 1 student excluded for withdrawing before the census date (EXCL 32)

Shifts in provision:

- -13 countable years (all column 2)
- 7 fewer non-completions (-25 → -18) (improved completion rate)

(The two lines above are also the same as for the 'normal' scenario)

• -43 Home & EU fundable years, +26 non-fundable, +4 I&OS

(Note all changes below are changes to the number of fundable years)

- -15 full-time years, -28 part-time
- -7 price group B, -36 in C2
- -57 undergraduate, +14 PGT (other)
- -43 Standard length years,

Individualised file (errors)

- Foundation Degree in sports coaching: all 30 students have their source of funding (LEARNDELFAM_SOF) set as 105 (ESFA) instead of 1 (HEFCE).
 - This makes 26 of them non-fundable.
 - For the other four, they also have DOMICILE set as CA (Canada), which makes them island and overseas
 - Accounts for 15 fewer full-time and 15 fewer part-time, all in price group C2
- BEng in Electrical Engineering: all 15 students have a FUNDLEV set to 20 (Postgraduate taught) instead of 10 (Undergraduate).
 - Accounts for a decrease of 14 fundable undergrads and increase of 14 fundable PGT (Other)
- Plus the differences present in the 'normal' version (7 fewer non-completions and -13 years in column 2)
