Competing and thriving in the new HE environment: challenges to the HE business model

One year on from FSSG's last conference, I am writing to let you know about our event on Friday 29 June 2018 to launch the findings and recommendations from three projects:

- Understanding income cross flows: changes and challenges to the HE business model
- How institutions fund and sustain medium scale research facilities
- Different by design exploring alternative delivery of undergraduate provision; benefits and opportunities (project led by the TRAC Development Group)

This event is intended for the senior leadership within higher education institutions, primarily those not in finance roles. We are hoping to attract colleagues from a range of backgrounds and perspectives – e.g. Deputy Vice-Chancellors/ Pro-Vice-Chancellors responsible for academic and research portfolios, and Registrars (or equivalent roles). Delegates will find out about our work and be involved in discussing current and future issues affecting financial sustainability in different types of institutions across the sector.

We hope that all HEIs will wish to send a representative, and that you will agree within your senior management team who should attend from your institution. To ensure that all HEIs have an opportunity to attend we will limit places to one per institution for a period of time, but if you would like to nominate an additional representative to attend, we will consider these requests if we have places available. The event is free to attend and we would hope you are able to send a very senior representative from your team. The feedback we had from last year's event was very positive and helped shape these projects.
