#### Who carries out the National Student Survey and why?

The National Student Survey (NSS) is being carried out by Ipsos MORI, an independent research agency, on behalf of the Office for Students (OfS)

The Office for Students ("OfS") is the regulator of the higher education sector in England and has certain statutory functions set out in the Higher Education and Research Act 2017. You can find more information about OfS and the work that we do on our website: www.officeforstudents.org.uk

OfS is committed to protecting your personal information and being clear about what information we hold about you and how we use it. This privacy notice tells you what to expect when the OfS collects personal information.

OfS is registered as a data controller with the Information Commissioner's Office (ICO). Our registration number is ZA309955 and you can check our entry details on the ICO's website: https://ico.org.uk/about-the-ico/what-we-do/register-of-data-controllers/

The NSS forms part of OfS's legal requirement under this Act to ensure the quality of higher education in the institutions it funds.

OfS has also appointed a data dissemination provider, currently Texuna Technologies Ltd, to disseminate the results of the survey to participating institutions and students' unions.

OfS has also commissioned the survey on behalf of the Higher Education Funding Council for Wales (HEFCW), the Department for Economy Northern Ireland (DELNI), Health Education England (HEE), the Scottish Funding Council (SFC) and participating private higher education providers. These bodies are responsible for funding the survey. OfS may share student information, or parts of it, with these bodies who also use the survey results in the exercise of their statutory functions.

OfS, HEFCW, DELNI and SFC have a statutory role in ensuring the quality of teaching in higher education is assessed, and OfS and its partners believe that students' views should form an important part of the assessment. We will not disclose your information to any other organisation outside of those listed here.

On 1<sup>st</sup> April 2018, HEFCE was replaced by the Office for Students (OfS), a new public body, established in law by the Higher Education and Research Act 2017. From this date forward, all HEFCE duties relating to this survey were transferred to the OfS.

## What is the purpose of the NSS?

The higher education funding bodies and the government have agreed that there should be a regular national survey of students to obtain their views on the quality of the teaching, assessment, and support experienced. The NSS is an annual survey that gives students the opportunity to provide feedback on their learning experience.

The NSS also aims to assist future generations of higher education students in their choices of what and where to study, by allowing them to see anonymous feedback on subjects and institutions. It surveys students at higher education institutions in England, Wales, Northern Ireland and Scotland and students studying higher education courses in directly-funded further education colleges in England, Northern Ireland and Wales. Results are publicly available each year via the Unistats website.

## Who sees my personal information and how are my contact details obtained?

OfS may, from time to time, engage other non-statutory bodies or agents to carry out functions on their behalf. OfS has appointed Ipsos MORI to carry out this survey (NSS). Student information is initially collected by the Higher Education Statistics Agency (HESA) and the Education and Skills Funding Agency (ESFA) and supplied to OfS. OfS then requests student contact details from Higher Education Institutions, Further Education Colleges and Alternative Providers to be passed to Ipsos MORI in order to be able to conduct this survey. OfS, the statutory authority, will retain control of any personal data transferred under contract with non-statutory bodies.

For the purposes of the NSS, Ipsos MORI is acting as survey agent on behalf of OfS. OfS has a data protection agreement in place with Ipsos MORI, which provides the necessary protection under the law to safeguard students' information. For example, they are forbidden under contract with OfS from using the NSS data they have for any other purpose.

OfS also has a data protection agreement in place with Texuna Technologies Ltd, the organisation that currently disseminates the results of the survey and who receives parts of your survey data in a non-identifiable form. The agreement provides the necessary protection under the law to safeguard students' information.

OfS is committed to protecting your personal information and being clear about what information we hold about you and how we use it. OfS is the "data controller" of any personal information collated and transferred under contract with these survey agents. Your personal information will be kept strictly confidential by all parties involved, will be stored securely within the European Economic Area and will not be transferred outside that territory.

## What personal information do you collect about me?

The information we will collect as part of this survey is set out below:

- Names
- Date of birth
- Gender
- Contact details
- Course details
- Unique identifiers
- Ethnicity
- Religion (if applicable)
- Disability (if applicable)
- Survey responses
- Language preference (Welsh)

We can assure you that you will NOT be identifiable in any published results.

We also collect meta-data such as screen resolution, method of participation and time taken to complete the survey. This information is used only for survey development and evaluation purposes.

#### How long will your personal information be held for?

Your personal data will be used for the purposes of the NSS only. All student contact details will be destroyed soon after the survey is complete, and Ipsos MORI will securely remove all other student data from their computer systems and transfer it to OfS. All data held by Texuna Technologies Ltd will be securely deleted at the end of the contract period.

Responses to the NSS will be retained indefinitely by OfS for use in producing statistical analysis and research into quality and student experience, and trends in higher education. The information will not be used to make any decisions about individuals and any reports we publish will not include individualised data.

#### How will the information I provide be used?

Your responses to the NSS will be used solely for research purposes, which includes providing information to allow the UK HE funding bodies to fulfil their statutory roles. The results of this research will be anonymous and provided in the form of statistical information only. We can assure you that you will NOT be identifiable in any published results.

Your participation in this research, together with your individual responses to the questions, will be kept strictly confidential in line with information security requirements and standards as agreed between Ipsos MORI and OfS. We can also assure you that any information you provide during this research will NOT be used for marketing, nor will we sell your information to any third parties. ## Do I have to take part in the survey?

Participation in this research is voluntary; you do not have to take part. You can also ask <a href="MORI">Ipsos</a>
<a href="MORI">MORI</a> to remove your details from the contact list being used for this survey, but Ipsos MORI will ask you to confirm your details to ensure that the correct records are removed from the database. It is important that students verify their identity so the NSS provides robust data for potential students and their advisors to make informed choices. If a student opts out at any stage, all personal information (contact details, date of birth, etc.) will be securely and permanently deleted from the contact list used for this survey and they will not be contacted by Ipsos MORI or OfS again.

In exceptional circumstances, it may be necessary for OfS to analyse student-level data relating to refusals or opt outs. In this case, Ipsos MORI will securely transfer data to OfS about students who have actively opted out of the survey.

#### How will the results of the survey be used?

OfS and the above bodies will use the results of the survey for the following purposes:

To publish aggregated and anonymised results of the survey in the following ways:

- Published 'in context' on the websites of institutions via a 'widget'. This is a small web
  application that displays information from the Unistats website for the course which the user
  is viewing.
- Published on the Unistats website that enables users to search and compare information about courses and institutions.
- Data are also envisaged to be available via the UCAS course search tool (Course Finder),
  which will incorporate the Key Information Sets (KIS) data so users can view the data at the
  same time as viewing the courses to which they are interested in applying.
- For analysis. This may result in the UK funding bodies undertaking research or the release
  of data, including any open comments that you may make, to OfS approved users (on
  behalf of the other funding councils), such as academic researchers and sector
  organisations for the purpose of conducting analysis or research to enhance quality within
  Higher Education. OfS will retain control of the data under contract with such users or if that
  user is subcontracting, we will require they have the same controls. Reports will only
  present anonymised and aggregated data.
- To provide summary feedback to individual institutions. These data will be provided to institutions to help them identify where their strengths lie and also how they can make improvements. This summary feedback will be aggregated and anonymised, ensuring no individual student can be identified. These results may include the text of any comments that students provide at the end of the questionnaire. This text will not be attributed to individuals and students are advised to avoid making comments that: could enable them to be individually identified; name individuals; or make references that could identify an individual. Although names are removed from the NSS feedback, it may still be possible for those working at an institution to identify themselves and colleagues. Therefore, such information may be personal data and institutions are asked to bear this in mind when processing the data.

## **Optional questions**

Some institutions ask their students optional or institution-specific questions. These questions are asked via the online survey only and provide additional confidential feedback to institutions. Of and the above bodies use the information for the following purposes:

- To provide summary feedback to individual institutions. These data will be provided to institutions to help them identify where their strengths lie and how they can make improvements.
- For statistical analysis. This may result in the release of data to other approved users, which may include academic researchers. OfS will retain control of the data under contract with such users or if that user is subcontracting, we will require they have the same controls. Reports will only present anonymised and aggregated data.
- These data will **not** be published on the Unistats website.

- Institutions may use the results of their own optional questions (this includes any institution-specific questions and questions from the optional bank of questions) publicly, should they wish, in marketing and publicity materials. However, the following principles must apply:
  - If results are to be used in this way, the publication thresholds of both 10 respondents and 50% response rate per cohort must be adhered to;
  - Free text comments should not be used in publicly available materials in order to preserve the anonymity of students; and
  - Institutions should not attribute these results to the NSS.

Although names are removed from the NSS feedback, it may still be possible for those working at an institution to identify themselves and colleagues. Therefore, such information may be personal data and institutions are asked to bear this in mind when processing the data.

#### Can I provide feedback on the NSS?

#### How can I exercise my rights under the data protection legislation?

# How do OfS and Ipsos MORI ensure your personal information is held securely?

OfS and Ipsos MORI take responsibilities to keep your personal information secure very seriously. As such, we take every reasonable precaution to ensure your information is protected from loss, theft or misuse. ### **Eligibility criteria:**

Final year students and equivalent:

- Students expected to be in their final year.
- Students on flexible programmes where the final year cannot be predicted, after they are expected to have undertaken more than one full-time equivalent (FTE) and not before their fourth academic year of study.

Students with the following funding arrangements:

- Students on Initial Teacher Training courses funded by the National College for Teaching and Leadership.
- Students studying NHS-funded subjects.
- All students studying on directly funded, prescribed Higher Education courses at Further Education Colleges/Further Education Institutions in England, Wales and Northern Ireland.

However, the following are not eligible:

- Students on programmes that do not lead to undergraduate qualifications or credits.
- Students on a course lasting one year or one FTE or less.
- Any students who were eligible in the NSS 2018 (whether or not they responded) and who remain at the same institution.
- Students under the age of 16.

Students are included in the 2019 survey population if they are expected to complete their course between 1 February 2019 and 31 January 2020 inclusive.
