## Explanation of amendments to the OfS's regulatory framework

Following our consultation on revisions to our publication of information policy,<sup>1</sup> we are making amendments to the regulatory framework, with effect from 30 September 2022.

We have reproduced the relevant sections of the regulatory framework published in February 2018, below. Where our amendments will result in deletion of text from the regulatory framework, this is shown as follows: deleted text. Where our amendments will result in the addition of text to the regulatory framework, this is show as follows: additional text.

Paragraph numbers are those of the regulatory framework.

This document is for information purposes only and does not form part of the regulatory framework.

## **Content of the Register**

- 71. The Register will provide a single, authoritative reference for students, businesses, providers, other regulators, and members of the public about a provider's regulatory status.
- 72. The Secretary of State for Education has laid regulations under section 3(6) of HERA<sup>2</sup> to set out the information that must be contained in a provider's entry in the Register. In addition, the OfS has decided that further information should also be published for each provider in the interests of transparency. Both categories of information are set out in the table below, with those items required by statute identified by an asterisk. We have published a general policy in relation to publication decisions<sup>3</sup>.
