Full privacy notice

The Office for Students ('OfS') is the regulator of the higher education sector in England and has certain statutory functions set out in the Higher Education and Research Act 2017. You can find more information about OfS and the work that we do on our website: <u>www.officeforstudents.org.uk</u>

The OfS is committed to protecting your personal information and being clear about what information we hold about you and how we use it.

The OfS holds webinars, events, workshops and conferences to promote its work as a regulator and to support its statutory functions. Zoom is the software used to deliver and manage webinars, allowing participants to log in and attend webinars at the time or view the webinar later.

Any personal information you submit when you register with Zoom or log in to Zoom to attend a webinar or view a webinar will be stored by, and accessible to, Zoom. Please only submit personal data which you are happy to have processed. Here is Zoom's privacy policy: <u>https://zoom.us/privacy</u>

How we will use your information

We can only use your personal information where we have a specific purpose or purposes for doing so.

The OfS holds webinars for universities and other organisations about our work as the regulator of the higher education sector in England. We use Zoom as a tool to hold these webinars and to ensure that only those invited may log in to a webinar.

To achieve the above aims, we will process your personal data for the following specific uses:

- to send out webinar invitations to individuals, who have signed up to receive our emails, and to confirm attendance for invited attendees only
- to provide participants with further information about the webinars
- to facilitate networking between participants at online events, attendees may be invited to submit via the registration form, question and answer (Q&A) or chat feature the following details:
 - name of provider or organisation
 - details of the networking opportunity they are interested in pursuing
 - generic email address that does not feature the name of a specific individual
 - permission to feature these details in the recording of the event.

These details will be published for other attendees to view during the online event. They will also be included on PowerPoint slides to ensure the information is captured on the event recording. Recordings of online events are hosted on the OfS YouTube channel

• to email a post webinar evaluation survey to ascertain how well the webinar was received; and to email a link to the recording of the webinar.

If we would like to use your personal information for a reason other than those purposes set out above, we will inform you of this before we start this processing, and we will provide you with further information about the new purpose/s.

Legal basis for using your personal information

Under data protection legislation, we require a legal basis to be able to process your personal information for the purposes set out above.

In this case, the legal basis is:

• that processing the personal information is necessary for the purposes of the OfS's legitimate interests [GDPR Article 6(1)(f)].

Legitimate interests

We have a legitimate interest in collecting your personal information to ensure that the OfS has the necessary information to host webinars effectively and to ensure that only invited individuals attend webinars or view webinars later.

These webinars will provide opportunities to support our providers and other organisations in the higher education sector, and are forums to provide advice, guidance, and updates about OfS work.

Participant lists for OfS webinars

- The OfS will hold a list of individuals who will be invited to attend webinars. Individuals will have the choice to attend the webinar, or to view the webinar later.
- You will be informed of our privacy policy when you log in to Zoom, and how we are processing your personal information.

Special category data

We do not collect special category data for Zoom webinars.

What personal information we will collect

For individuals who are logging in live, we will collect the following personal information:

- name
- email address
- job title
- organisation
- collecting device and location information
- IP address
- local IP (IP of device)
- network type
- type of microphone (for presenters)
- data centre
- collection type (joining and leaving webinar reasons and times).

For individuals who view the webinar later, we will collect the following personal information:

- name and email address
- collecting date of view.

With whom we share your personal information

As your personal information will be submitted by logging in to Zoom, any personal information you submit will be stored by, and accessible to Zoom.

Zoom processes personal data in accordance with its own privacy policy: https://zoom.us/privacy

Please only submit personal data, which you are happy to have processed, in accordance with Zoom's privacy policy.

We will not disclose your information to any other organisation except where required to do so as part of our functions or by law.

Where your personal information will be stored

Zoom is an American communications technology company based in California. Zoom confirm in their privacy notice that they are certified with the Privacy Shield, which provides organisations in the US with a way of showing that they provide adequate protection to the personal information of EU citizens. Your personal information will be stored in the European Union/EEA. This means that your personal information is protected under the GDPR. Zoom, in certain cases, will transfer data from the EU.

How we protect your personal information

The OfS is accredited to Cyber Essentials Plus to demonstrate and assure our commitment to good practice in cyber security. Within the OfS, the information will only be accessible to designated members of our external relations team, IT administrators, and members of governance to carry out compliance activities. Your rights over your personal information

When your personal information is collected, you have certain rights in relation to that personal information that may be exercised. You have the right to request:

- a copy of your personal information
- inaccurate personal information held about you is corrected
- your personal information is deleted
- processing of your personal information is restricted
- a copy of your information in a format that allows easy transfer 'data portability'
- that you are not subjected to automated decision making or profiling (if these take place).

All these rights have certain limitations depending on the request and the purpose for which we are holding your personal information. Further information can be found about these rights and our

Zoom's privacy policy states that you can request access to personal data from their Privacy Team at privacy@zoom.us.

How long we will hold your personal information

We are only able to retain a copy of your personal information for as long as it is needed for the purposes for which is was collected. Cloud recordings are retained for 30 days, and meeting metrics are retained for 12 months.

If you choose to attend a webinar through Zoom, any personal data processed will be retained for as long as is considered necessary by Zoom, and in accordance with their privacy policy. Information on how to delete your Zoom account can be found on Zoom's privacy notice.

Use of cookies on the OfS website and on Zoom

Cookies are test files placed on your computer to collect standard internet log information and site visitor behaviour information. This information is used to track visitor use of the website and to complete statistical reports on website activity.
