

Location table – which locations to include

- The Location table records teaching locations for OfS-fundable students in the HESES18/HESF19 population, for the purpose of calculating location-based funding allocations.
- Locations are always those of **providers**, even though some students may be studying by distance learning, on a work placement or on a study year abroad.
- You should complete a row for:
 - 1. Each of your provider's own locations;
 - 2. Each location of a provider that teaches students on your behalf under a **subcontractual arrangement**.
- If a number of locations for a provider fall within a single local authority district or unitary authority, these can be treated as a single location.
 - In general, we would not expect buildings that are part of a single campus to be identified separately.

Location table – which locations to include

- See paragraph 192 in Part 1 of 'HESES18 Higher Education Students Early Statistics survey 2018-19' (OfS 2018.40) or 'HESF19 Higher Education Students Forecast 2019-20' (not yet published) for guidance on how to record locations for:
 - Distance learning
 - Learning in the workplace, work experience and study abroad
 - Joint courses

Location table – how to record locations

- 1. Select one of the two entries on the 'Location type' drop-down list:
 - a) Other when entering one of your provider's own locations.
 - **b)** Subcontracted out when entering a location for a provider that teaches students on your behalf under a subcontractual arrangement.
- 2. Enter the UK Provider Reference Number (UKPRN) of the provider.
 - If you select 'Other', this column is auto-filled with your provider's UKPRN.
 - If you select 'Subcontracted out', you must enter a valid UKPRN that is not your provider's UKPRN.
 - If you subcontract to a provider that **does not have a UKPRN**, you may use the following **generic codes** (as defined by HESA):
 - 4002 Other non-UK provider
 - 4003 Other public body in the UK
 - 4004 Other private body in the UK

Location table – how to record locations

- 3. Enter the name of the location.
 - This will auto-fill with the provider's name when a valid UKPRN is entered.
 - If you have used a generic code, you should enter the provider's name. For HESES18, this should match the name entered in Table 6 in the 'Name of provider without a UKPRN' column.
 - If all teaching at the provider is delivered at **one location**, then the **provider's name** is sufficient information for this cell.
 - If teaching at the provider is delivered at **more than one location**, you should enter, in addition to the provider's name, a **name to identify the location unambiguously**, e.g. 'Main Campus'.
- 4. Enter the postcode of the location.
 - If you have used generic code '**4002**' (Other non-UK provider), then you should enter '**NA**' as the postcode.

Location table – recording years of instance

- 5. In Section 1, enter the estimated completed **OfS-fundable** years for each price group.
 - The total for each price group (displayed above row 1) should be equal to the corresponding total calculated from:
 - For HESES18: OfS-fundable years in Column 4 of Tables 1, 2 and 3.
 - For **HESF19**: the years in **Section 1** of **Table 1**.
 - Under the following circumstances, non-integer values (rounded to two decimal places) may be entered:
 - 1. Where years of instance are **split across price groups**;
 - 2. Where students are **taught at more than one location**. Years of instance should be split according to the **proportion of teaching activity** that takes place at each location.

Location table – recording full-time equivalence

- 5. In Section 2, enter the estimated **OfS-fundable** FTE for each price group.
 - The total for each price group (displayed above row 1) should be equal to the corresponding total calculated from:
 - For **HESES18**: the data in **Tables 1, 2 and 3**.
 - For HESF19: the FTEs in Section 2 of Table 1.
 - Values should be rounded to two decimal places.
 - A value must be entered if a value has been entered in Section 1 for the same price group.

Location table – comparing with Table 6

This doesn't apply for HESF19

- Valid UKPRNs and generic codes you enter into Table 8 are compared with those that you enter into Table 6 (Subcontractual), where the fundability status for the countable years is 'Home and EU, OfS-fundable'.
 - A validation failure message will be shown if a valid UKPRN or generic code is entered in Table 6 but not in Table 8, or vice versa.
- Please ensure that:
 - locations are recorded for all providers that teach students on your behalf under a subcontractual arrangement;
 - locations for any provider without a UKPRN can be matched to a provider entered in the 'Name of provider without a UKPRN' column in Table 6.
